### Prior to Arriving in United States

- Sign page 1 of your I-20 as soon as it arrives
- Secure housing arrangements

  - Valid passport containing F-1 visa (except visa-exempt Canadians)
  - Original Signed Form I-20
  - Acceptance letter
  - Financial support statements
